- A. Flasch in response to meeting with multiple houses of worship and facility security coverage. Some houses of worship feel targeted (Jewish and Muslim congregations). Having security personnel on site with the ability to be armed will slow down an assailant.
 - Security Guard funding \$40K cap, getting \$1 million out the door. Helps to offset the cost of security, bridges the gap.
 - Designated for NGOs and Houses of Worship. Grant. Many will apply, will get evaluated based on grant criteria, then award.
 - \$15mm for physical upgrades for facility.
