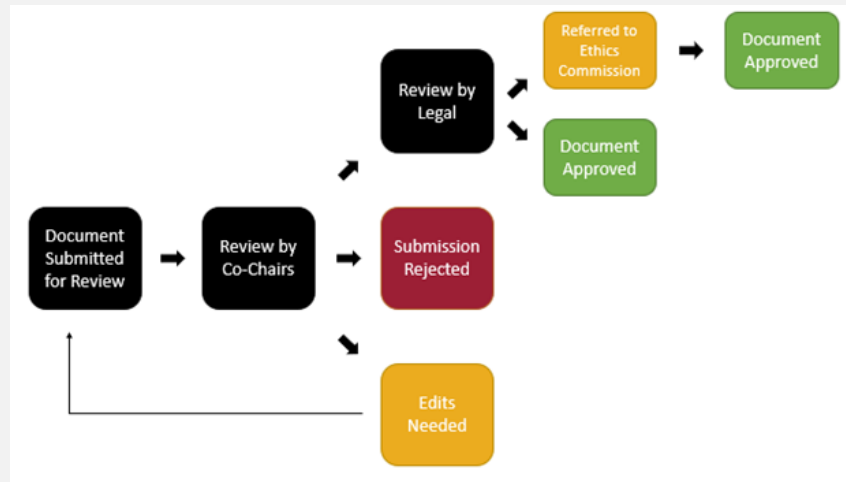

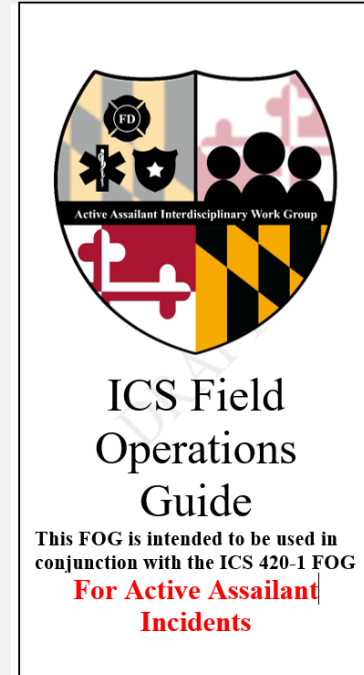

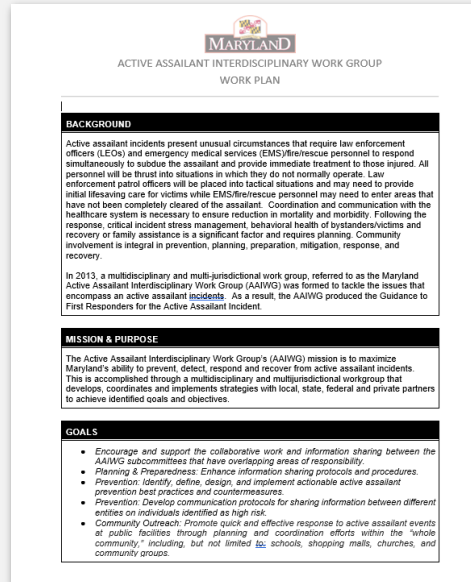
# Field Operations Guide (FOG)
